Our analysis of business partnering models revealed a well-balanced audience: **Out-licensing led with 40%, closely followed by In-licensing at 35%**. Regional partnerships and distribution accounted for 30%, commercialisation 25%, product acquisitions 20%, co-development 18%, technology transfer 12%, global rights 5%, and financing at 3%.

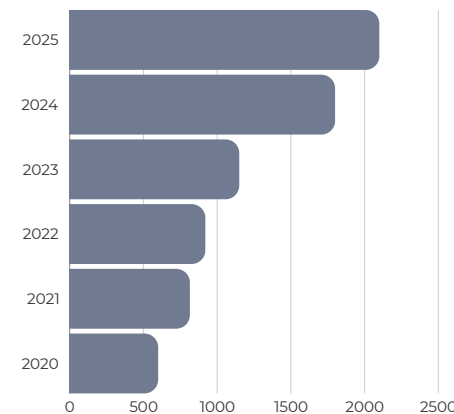

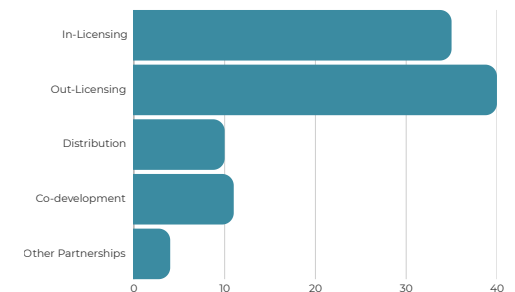

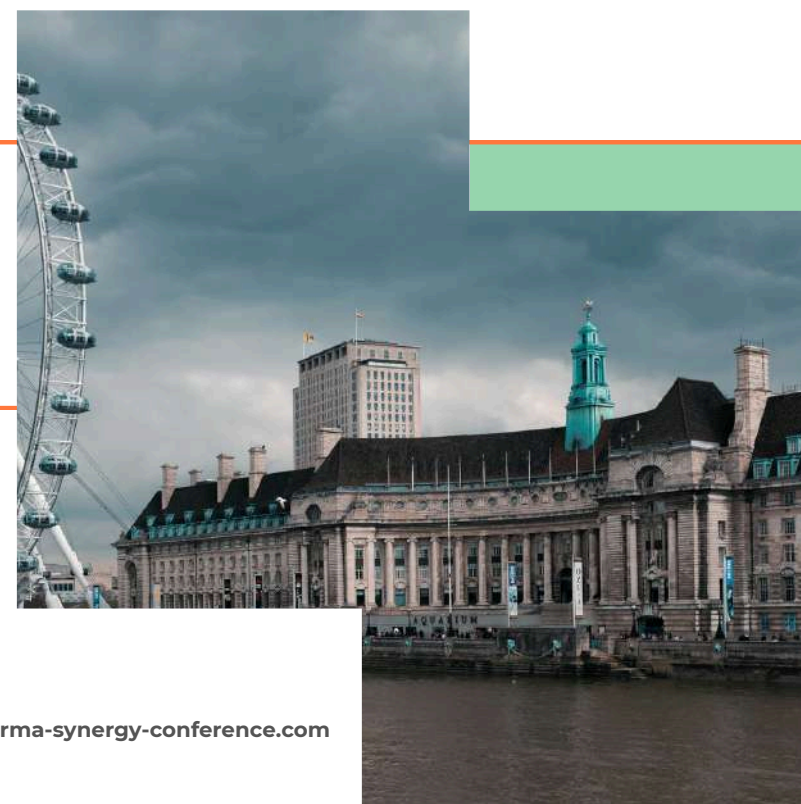
